Ready-to-use FINAL BLOX is easy to distinguish with its distinctive red color and unique cog-like shape. FINAL's multi-edge design gives rodents plenty of gnawing edges. This weatherable 20 gram Blox easily fits down burrows, in tight baiting areas and in bait stations. A hole in the center of the Blox lets PCOs place it on bait securing rods or wire/hang FINAL BLOX for added security.

FINAL BLOX complements Bell's superior line of rodent baits, offering PCOs another tool against rats and mice. FINAL is especially effective on mouse populations that are difficult to control or where resistance is suspected.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

READ THIS LABEL: Read this entire label and follow all use directions and use precautions.

IMPORTANT: Do not expose children, pets, or other nontarget animals to rodenticides. To help to prevent accidents:

1. Store product not in use in a location out of reach of children and pets.
2. Apply bait in locations out of reach of children, pets, domestic animals and nontarget wildlife, or in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. Even stronger bait stations are needed in areas open to hoofed livestock, raccoons, bears, or other potentially destructive animals, or in areas prone to vandalism.
3. Dispose of product container and unused, spoiled, and unconsumed bait as specified on this label.

USE RESTRICTIONS:

For control of Norway rats, roof rats and house mice in and around homes, industrial, commercial, agricultural and public buildings, and similar man-made structures. FINAL[®] BLOX may also be used in transport vehicles (ships, trains, aircraft) and in and around related port or terminal buildings. This product may also be used in alleys and sewers. Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in direct contact with food. Do not broadcast bait. When used in USDA inspected plants, this product must be applied in tamper-resistant bait stations.

SELECTION OF TREATMENT AREAS: Determine areas where rats or mice will most likely find and consume the bait. Generally, these are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Remove as much alternative food as possible.

STATEMENT OF PRACTICAL TREATMENT

If Swallowed: Call physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. If person is unconscious, do not give anything by mouth and do not induce vomiting.
If on Skin: Wash with plenty of soap and water. Get medical attention if symptoms persist.

DIRECTIONS FOR USE (Continued from other panel.)

APPLICATION DIRECTIONS:

Each bait block in this container weighs nearly 3/4 ounce (20g).

RATS: Place 5 to 22 FINAL[®] BLOX (usually at intervals of 15 to 30 feet) per placement. Maintain an uninterrupted supply of fresh bait for at least 10 days or until signs of rat activity cease. For use in sewers, securely attach one end of wire to FINAL BLOX and the other end to a stationary structure such as the bottom step of a manhole ladder or a sewer grate. Allow just enough wire for the block to rest on manhole benching. If benching is not present, suspend block a few inches above the high water mark or secure FINAL BLOX on a board supported by opposing steps of the ladder. Securely attach FINAL BLOX in this manner will prevent removal by rats or water. Use at least #5 FINAL BLOX per manhole. Maintain an uninterrupted supply of fresh bait for at least 10 days or until signs of rat activity cease.

MICE: Place 1 block per placement. Space placements at 8- to 12-foot intervals. Two FINAL BLOX may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days or until signs of mouse activity cease.

RATS AND MICE: Replace contaminated or spoiled bait immediately. Collect and dispose of all dead animals and leftover bait properly. To prevent reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.

PRECAUTIONARY STATEMENTS

HAZARD TO HUMANS AND DOMESTIC ANIMALS

CAUTION: May be harmful or fatal if swallowed or absorbed through the skin. Causes moderate eye irritation. Avoid contact with eyes, skin or clothing. Wash thoroughly with soap and water after handling bait.

ENVIRONMENTAL HAZARDS

This product is toxic to fish, birds, and wildlife. This product can pose a secondary hazard to birds of prey and mammals. For terrestrial uses, do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark.
