

Bullet Lures do not contain ingredients in any quantity to be hazardous. Active ingredients are synthetic insect pheromones contained in polyethylene vials in quantities less than 100 mg. The synthetic insect pheromone is mixed in a solution of hexane for loading purposes. Quantities of hexane are also less than 100 mg.

The synthetic insect pheromone mixed in with hexane solvent is generally clear in appearance. This clear solution is injected into the polyethylene vials into colored plastic balls.
